## A. EXECUTIVE SUMMARY

2021 was yet another year living with the pandemic. The Covid-19 pandemic has posed significant challenges and Slovak authorities, like in the rest of the world, has continued to struggle with them. These challenges also involved the area of gender equality. According to Gender Equality Index 2021, in general, Slovakia reached 56 out of 100 points (12 points below EU's score) and ranked 24th in the EU on the Gender Equality Index<sup>1</sup>.

2021 was also the year of the Domestic and Gender-based Violence Programme resumption. The projects under the gender equality call (SGS, DGV01) were finally approved by the Programme Operator and the project contracts for all nine projects in amount of 1 530 703 EUR were concluded. Two projects include a donor project partner from Norway, KUN and Sex and Politikk.

In summer – autumn 2021 the projects started their implementation. Within the projects, there are nine institutions active in the field of gender equality to be supported directly as a project promoter and/or project partner. One of the project ensures through its activities support of about twenty organizations based on the webpage “stopviolence”.

Regarding the almost one-year delay in implementation of the projects the start of the implementation was focused on re-establishing contacts with primary and secondary schools, in which the lectures focused on gender equality are going to be provided. However, 14 lectures in 7 schools have already been provided by one of the projects.

Two exhibitions and a theatre performance took place this year as a part of awareness-raising campaigns promoting gender equality connected with the worldwide action 16 days of activism against violence against women.

In the project (DGV01004) *Gender Equality Promotion (GEP)* the Norwegian partner KUN also cooperate with Arni Hole – the Norwegian expert in gender equality and gender-based violence who, together with other Norwegian experts, participated in the public discussion “Gender equality in Norway: An example for Slovakia?” The event was held in hybrid form and shared via Facebook. Until 30 November 2021, it had a range of 6,900 people.

Two Open calls within the Outcome 2 - *Victims of domestic and gender-based violence protected and supported* were launched and closed: the call no. 1 (DGV02) focused on support of intervention teams at local level on services for victims of domestic and gender-based violence and call no. 2 (DGV03) focused on improvement of quality of services so that they meet the required European standards, both including specific services for children victims.

In December 2021 within the call no. 1 (DGV02), the Selection Committee recommended six projects for support and one project on the reserve list; within the call no. 2 (DGV03) there are three projects recommended for support. The decision on awarding the grants for the recommended projects will be issued in the 1<sup>st</sup> half of 2022.

The pre-defined project (DGVPP002) “*Improving the victim-oriented approach – a tool enhancing the capacity to fight violence against women and domestic violence*” is already being implemented by the Institute for Labour and Family research. In 2021, coordination meetings with partners were held and solved the questions of practical implementation of the project such

as time schedule update, clarification of the needs, scope and content of trainings for police officers of the first contact and for investigators.

Regarding the significant delay in the programme implementation the Programme Operator submitted the programme modification proposal to the donor in order to transform the call on support of specific target groups to the new predefined project Sexual Assault Centre in Bratislava and to support the organizations focused on work with specific target groups by the bilateral fund. The Programme Operator appreciates a lot the fruitful cooperation regarding this with the programme partners – the Norwegian Directorate of Health, the Council of Europe, the Ministry of Labour, Social Affairs and Family of the SR and the Financial Mechanism Office.

## B. PERFORMANCE

### 1. Programme context

The Covid-19 pandemic has posed significant challenges also in., the area of gender equality. Whilst pandemic revealed the critical state of support services for victims of gender-based violence already last year, the issue still has not been solved. The fact that Slovak Republic has not yet introduced a systematic method of financing women's shelters and specialized providers of assistance for women experiencing violence and their children has created the space of uncertainty where it is difficult for helping organisations to operate and victims of gender-based violence does not get sufficient support, help and assistance.<sup>[1]</sup> To cover the financial gaps and to enable functioning and to prevent a collapse of support network, the office of the prime minister released three million Euro that were distributed to organisations helping women on the application basis.<sup>[2]</sup> The financial situation of some organisations helping victims of gender-based violence has been improved by gaining status of intervention centre, receiving grants from Ministries of Labour, Social Affairs and Family<sup>[3]</sup> and Justice.<sup>[4]</sup>

The non-government organizations (hereinafter referred to as “NGOs”) and helping organisations have also reported increasing bias against women – survivors of gender-based violence.<sup>[5]</sup> It has been reported that abuser is using and twisting court and social system as another weapons against survivors. Abuse cases are by relevant authorities treated as high-conflict separations and the system perpetrates prejudices against survivors and work on stereotypes on gender-based violence.<sup>[6]</sup> The increasing bias against mothers might also be the result of aggressive campaign and lobbying from so-called fathers organisations claiming „parental alienation.“<sup>[7]</sup>

The Ministry of Justice in an amendment of the Act approved on May 7, 2021, created a network of so-called intervention centres. This model is based on interconnecting police intervention with crisis intervention and expert assistance provided to a victim or person under threat of domestic violence immediately after domestic violence occurs.

In the course of the year, there were various attempts<sup>[8]</sup> to pass bills related to gender equality, none of them successful. Most of them related to the legislation regulating the termination of pregnancy, two attempted to widen the range of childcare facilities. All proposals were subject to a close public scrutiny.

In 2021, important documents on gender equality were adopted. First, the National Strategy for Gender Equality and Equal Opportunities 2021-2027 and the corresponding Action Plan were adopted on 28 April 2021.<sup>[9]</sup> They focus on areas that significantly affect the gender equality in

Slovakia. These include violence against women, bullying and sexual harassment, discrimination against women in education, science and research, discrimination against employed women and jobseekers, the gender pay gap, invisible labour, women, and their representation in positions of power, and guaranteeing gender equality at the institutional level. The Action Plan contains a number of particular objectives, meeting of which will have a direct impact on improving women's quality of life.

The Department of Gender Equality and Equal Opportunities of the Ministry of Labour, Social Affairs and Family of the SR (hereinafter referred to as “MLSAF SR”) prepared a new action plan on Prevention and Elimination of Gender-Based Violence in cooperation with NGOs. It was approved in the Gender Equality Committee on 7 December 2021, and it was submitted to the government for approval on 17 December 2021. The Action Plan will complement the National Strategy for Gender Equality for 2021-2027. It lays down the basis for the provision of the institutional support for women being victims of violence and their children. Areas in the field of implementation include strengthening the legal and strategic framework, supporting existing and establishing new affordable support services, training for professions dealing with violence against women (law, medicine, psychology, theology, etc.), primary prevention, as well as monitoring and research. The task section of the action plan sets out very specific and targeted tasks to support women experiencing violence and their children.

The Department of Gender Equality and Equal Opportunities also prepared Summary Report on the State of Gender Equality in Slovakia<sup>[1]</sup>, which the Government acknowledged on 30 June 2021. Slovakia has also submitted its replies to the List of issues and questions prior to the submission of the 7th periodic report of Slovakia: Committee on the Elimination of Discrimination against Women.<sup>[11]</sup>

On 24 November 2021, the Government of the Slovak Republic at its meeting approved the material "Apology of the Government of the Slovak Republic for sterilization of women in violation of the law." The Government considers the practices of the previous regime between 1966 and 1989 relating to the reproductive behaviour of women from socially disadvantaged backgrounds, as well as the sterilizations between 1990 and 2004, to be unacceptable.<sup>[12]</sup>

Slovak Republic continued to struggle with pandemic of Covid-19 also in 2021. As in the previous year, it was a year full of challenges, gender equality included. The systemic failure to protect victims of gender-based violence is being addressed, but not solved, national parliament has discussed number of bills related to gender equality and several strategic documents specifically dealing with gender equality were adopted.

## 2. Programme results

### Outcome 1: Understanding of gender equality increased

#### *Description and analysis of results*

*The Outcome 1 was originally planned to be supported by way of the pre-defined project (hereinafter referred to as “PDP”) “HER STORY” and one small grant scheme (hereinafter referred to as “SGS”) DGV01 focused on capacity-building of organisations working in the field of gender equality and work-life balance. Based on the decision of the MLSAF SR as the project promoter of the PDP “HER STORY” not to implement the project and after mutual communication and agreement with the donor, the PDP was cancelled and funds were reallocated to the SGS.*

Finally, the Programme implementation was fully resumed in 2021. The allocation of the DGV01 call was increased to 1 800 000 EUR. The increase in allocation enabled to approve 7 projects recommended by the Selection Committee (hereinafter referred to as “SC”) for support within the first closure and all the three projects within the second round, including the project on the reserve list. By the decision of the Programme Operator (hereinafter referred to as “PO”) issued on 3 May 2021, 7 projects were approved for support within the first closure in amount of 1 242 086 EUR. On 22 July 2021, 3 projects from the second closure were approved in amount of 468 506 EUR. One applicant from the second closure decided not to implement the

project after all. The reason was situation with Covid-19 and changed situation in the organization affected by the situation at that time.

As the funds have not been fully committed, a part of the funds was proposed to be reallocated to the PDP “Improving the victim-oriented approach – a tool enhancing the capacity to fight violence against women and domestic violence”. There are no projects on the reserve list anymore and the PO considers the relaunch of the call as not efficient. There is not enough time that the further projects could be implemented in line with the original requirements of the call, and the number of organisations active in the gender equality is limited in Slovakia and most of them are already involved in the projects supported as a project promoter and/or project partner. Reallocation will not negatively affect the target values of the Indicators under Outcome 1 to be achieved.

The project contracts for all 9 projects were concluded in summer – autumn 2021 and the projects started their implementation. Based on the project applications data the target values of the indicators should be achieved at the end of projects implementation.

Within the projects, there are nine institutions active in the field of gender equality supported directly as a project promoter and/or project partner. Within the project DGV01010 *34all* “(three for all) - *Three substantial messages on CSE and SRHR for each target group*”, support of about twenty organizations based on the webpage “stopviolence” should be supported by the project activities.

The project promoters and their partners are dealing with methodological preparation of lectures, workshops and public and community discussions and clubs, including Roma community (DGV01005 project). Regarding the almost one year delay in implementation of the projects, the start of the implementation was focused on re-establishing contacts with primary and secondary schools, in which the lectures focused on gender equality are going to be provided. 14 lectures have already been provided to the 7 schools in three districts in Žilina Self-governing region – project DGV01008 *Women's rights are human rights*.

The project promoter of the DGV01008 project also implemented the Exhibition “Get out of the circle of violence” with the start on 25 November 2021 on the International Day for the Elimination of violence against Women. On the same day within the project DGV01003 *Various ways to equality* vernissage of the exhibition of cartoon humour “Caricature and cartoon humour against gender stereotypes” in the Regional Gallery in Prešov was held. The theatre performance VERSUS of the Odivo theatre depicting a woman - her shades, layers, positions that are present in her identity - an outline of a stereotypical perception of the feminine principle – took places in November, as well. Due to restrictions taken a day before the exhibitions opening, they were held online. These activities were a part of awareness-raising campaigns promoting gender equality connected with the worldwide action 16 days of activism against violence against women.

Within the projects DGV01006 *ESCAPE FROM (CO)DEPENDENCY* and DGV01005 *GENDER EQUALITY for ROMA COMMUNITY (GER)* motivational publications such as quartet “Invisible women”, women empowerment diary, women empowerment calendar 2023 ad quartet on important women are being prepared.

*Pre-defined project(s)*

The PDP “HER STORY” was cancelled in 2021. The paid advance payment was reimbursed to the PO and the agreement on project contract termination entered into force in November 2021.

## **Outcome 2: Victims of domestic and gender-based violence protected and supported**

### *Description and analysis of results*

The Outcome 2 was planned to be supported by way of 3 Open calls (Call no. 1 - DGV02, Call no. 2 - DGV03, Call no. 3 - DGV04).

The Call no. 1 (DGV02) on support of intervention teams at local level on services for victims of domestic and gender-based violence, including children, was launched on 14 May 2021. The total DGV02 Open call allocation was 3 329 412 EUR. The call was closed on 16 September 2021 and 10 project applications in total amount of 5 160 757 EUR were submitted. A donor project partner from Norway was involved in one of the ten project applications submitted. 8 project applications met the administrative compliance criteria and eligibility compliance and 6 of them were recommended by the SC to the PO for support in December 2021. One project was recommended for support on reserve list.

The call no. 2 (DGV03) on improvement of quality of services so that they meet the required European standards, including specific services for children victims was launched on 16 August 2021. The total DGV03 Open call allocation was 2 000 000 EUR. The call was closed on 2 November 2021, 3 project applications in total amount of 1 367 011 EUR were submitted. All 3 submitted project applications met the administrative compliance criteria and eligibility compliance and were recommended for support by the SC to the PO in December 2021.

Based on the preliminary results and data stated in the project applications recommended for support it is clear that no target values of all the indicators will be achieved. The target values of the outcome’s indicators related to the number of beneficiaries of services provided and share of the supported counselling centres meeting the European standards will be achieved. It is the same for the number of awareness raising and educational campaigns to be implemented by the centres and shelters. Target values of other indicators for outputs *Services for victims of domestic and gender-based violence preserved* and *Services for victims of domestic and gender-based expanded or enhanced* will not be achieved. The reason is the inappropriate set up of the results framework during the preparation of the programme concept note and high expectations and desire of the programme operator to support this area. Even though the programme still significantly contributes to the objective *Domestic and gender-based violence prevented and victims protected and assisted* and represents important support to the service providers, mainly the NGOs.

The call no. 3 (DGV04) on specialised services targeted at vulnerable groups, as well as perpetrators of violence is subject to the programme modification proposal submitted to the Donor by the Programme Operator in November 2021. In line with the original focus of the Programme Agreement, the aim of the DGV04 call was to implement two pilot projects on sexual assault units transferring best practices from Norway, one counselling centre working with perpetrators and support of two counselling centres providing services to specific target groups, such as victims of rape, victims with addictions etc.

Establishment of sexual assault unit has been considered demanding and takes time in order to be in good quality. The PO has been of the opinion that it would be a challenge to attract potential applicants. There have also been doubts, if 350 000 EUR (the maximum project grant to be applied for) is sufficient for implementation of such project in good quality and with international element of the Norwegian know-how transfer. There is also limited time for implementation of the projects within the Call no. 3 (ref. DGV04) – by 30 April 2024. Number of organizations active in the area and their capacity is limited. Based on the PO's experience and previous period's history there are not many organizations dealing with the specific target groups such as drug/alcohol addict victims or victims in sex business or working with perpetrators. Due to the persistent situation related to Covid-19 in various degrees of limitation of normal functioning, there is no precondition for the expansion of such organizations in such a sensitive and capacity and financially undersized area. The PO thus has not foreseen competition within the call. Some of the organizations have already been involved in the project submitted and approved.

Those are the reasons why the PO proposed to cancel the DGV04 call and reallocate the planned funds to the implementation of a new pre-defined project Sexual Assault Centre in Bratislava. The proposed pre-defined pilot project should contribute to Outcome 3 "Response systems more effective and integrated", if approved. The aim of the project is to prepare, set up and pilot the model of the Sexual Assault Centre that aims at assisting survivors and to provide medical care and forensic medical examination in cases of sexual violence in Slovakia.

The original plan, to support counselling centres for specific target group with specific needs and working with perpetrators will be implemented by using the funds from the bilateral fund at programme level and by involving NGO's into the implementation, if it is approved by the Joint Commission for Bilateral Fund.

#### *Pre-defined project(s)*

There are no predefined projects within the Outcome 2.

### **Outcome 3: Response systems to victims of domestic and gender-based violence improved**

#### *Description and analysis of results*

No Open call will contribute to the Outcome 3

#### *Pre-defined project(s)*

Two predefined projects were planned to be implemented under the Outcome 3 in line with the Programme Agreement.

The DGVPP002 "*Improving the victim-oriented approach – a tool enhancing the capacity to fight violence against women and domestic violence*" is implemented by the Project Promoter Institute for Labour and Family Research. The project contract was concluded in May 2021. There is a delay in the project implementation connected with the pandemic situation and suspension in the programme. The beginning of cooperation with the partners after re-starting the programme required more time as initially planned.

In 2021, cooperation meetings with partners were held and solved the questions of practical implementation of the project such as time schedule update, clarification of the needs, scope and content of trainings for police officers of the first contact and for investigators. The public procurement for customization of rooms in police stations to the needs of victims of domestic and gender-based violence has been prepared.

In November 2021, the Project Promoter submitted a request for predefined project modification. The need of the modification resulted from the communication with the Norwegian partner - the Norwegian centre for violence and traumatic stress studies (hereinafter referred to as "NKVTS") on the focus of the joint research activities, their range and methodology. The NKVTS requests to increase their budget in the predefined project. The original budget is insufficient for the planned scope of the research activities and additional 100 000 EUR are needed to cover all needs. The modification is a subject to the programme modification proposal submitted to the Donors by the PO. The proposed budget modification is crucial for the whole project implementation and can affect the bilateral part significantly.

The third Predefined project "Awareness raising and enhancement of the capacity to fight violence against women in Slovakia in line with Council of Europe standards" of the Council of Europe was cancelled. The Council of Europe decided not to implement the project due to contractual limitations. The funds were proposed to be reallocated to the new proposed project of Sexual Assault Centre in Bratislava.

### **Bilateral Outcome: Enhanced collaboration between beneficiary and donor state entities involved in the programme**

#### *Analysis of bilateral relations and achievements*

Under the DGV01 call, 2 out of 9 contracted projects include a donor project partners from Norway.

In the project DGV01004 *Gender Equality Promotion (GEP)* there is the Norwegian partner KUN involved. They also cooperate with Arni Hole – the Norwegian expert in gender equality and gender-based violence. The Norwegian representatives participated in the public discussion "Gender equality in Norway: An example for Slovakia?" It was held in hybrid form and shared via Facebook. Until 30 November 2021, it had a range of 6,900 people. In DGV01010 [\*34all" \(three for all\) - "Three substantial messages on CSE and SRHR for each target group"\*](#) the Norwegian organization Sex og Politikk is involved. The objective of the project is to create reliable online content in form of webpage, methodologies, lesson plans, worksheets, role plays, checklists and quizzes about sexual and reproductive health and rights in which the Sex og Politikk has more than 50 years of experience. Their main input will be sharing their know-how and expertise and giving feedback to the produced content in the project.

In 2021, the bilateral calls DGVB02 and DGVB03 were launched as complementary to the main calls DGV02 and DGV03 for search, establishing and development of the partnership and joint preparation of the project applications.

Due to Covid-19 situation and restrictions related to the travelling, no applications were submitted. On the Cooperation Committee meeting the reallocation of unspent funds was

approved. The bilateral initiatives were agreed to be implemented in 2022 and 2023 based on the appropriateness of the situation in connection with Covid-19 limitations.

Representatives from the Programme are active in the SYNERGY Network. This has been demonstrated in participation in two SYNERGY Conferences, a SYNERGY meeting, participation in the HELP Access to Justice for Women course, and in planning meetings for a potential 2023 SYNERGY Conference under the programme's bilateral funds. The SYNERGY Network increases the impact of the EEA and Norway Grants on policymaking when addressing domestic and gender-based violence in Europe, in line with European standards.

### ***Cooperation with the Donor Programme Partner***

The Domestic and gender-based violence Programme has one Donor Programme Partner (hereinafter referred to as "DPP") – the Norwegian Directorate of Health. The DPP is a member of the Cooperation Committee (hereinafter referred to as "the CC") and a member of the Selection Committee with voting rights.

In 2021 the Programme Operator organized 3 Cooperation Committee Meetings, 2 meetings were held per-rollam and 1 of them was held on-line. The topics of the per-rollam Cooperation Committee Meetings were the review of the Annual Programme Report 2020 and advising on the selection criteria and the texts of the Open calls DGV03 and DGVBF03. The on-line meeting was focus on review of the progress in the programme including advising on programme modification and on bilateral initiatives.

In December 2021, one Selection Committee meeting took place in connection with the Open calls DGV02 and DGV03. The DPP was actively involved in the Cooperation Committee and SC meetings, as well as in nomination of the evaluation experts for project applications evaluation in cooperation with the International Programme Partner (hereinafter referred to as "IPO"). The DPP has also closely cooperated in the matter of the proposed predefined project Sexual Assault Centre in Bratislava and involvement of the Norwegian project partner Oslo Sexual Assault Centre in it.

The Programme Operator very much appreciates this continued excellent cooperation with the DPP. The PO is also very satisfied with the FMO's cooperation, help and advices provided by them.

## **3. Implementation**

### **Cooperation with International Partner Organisations (IPOs)**

The Council of Europe is the IPO within the Programme.

The IPO is a member of the Cooperation Committee and a member of the Selection Committee with voting rights.

In 2021 the IPO participated in the already mentioned Cooperation Committee meetings related to review of the Annual Programme Report 2020, DGV03 and DGVBF03 text calls, including selection criteria and on-line review of the Programme Status, programme modification proposal and using of the bilateral funds. They also actively participated in the Selection Committee meeting on the results of DGV02 and DGV03 calls. In cooperation with the DPP

they were involved in nomination of the evaluation experts for project applications evaluation. The PO very much appreciated the inputs and advice of the IPO during the meetings and communication related to the Programme.

Within the last CC meeting the IPO informed the PO on dedicating funds (under the international Violence against Women project based in Strasbourg), in order to translate the HELP Access to Justice for Women course into Slovak. This contribution of the IPO in order to fight against the Domestic and Gender-based Violence in Slovakia from the IPO's own resources the PO appreciates very much. The IPO also implemented in 2021 HELP Access to Justice for Women course for the representatives of the Beneficiary states with the Domestic and gender-based violence programmes. The PO participated in the course and considers it very helpful, not only for the programme of domestic and gender-based violence, but also for the implementation of other programmes. The IPO also trained additional 2 trainers in Slovakia to implement the HELP Access to Justice for Women course. One of the trainers is the senior manager of the Coordinating Methodical Centre (hereinafter referred to as "CMC"), who proofread the course and plans to run the course in 2022.

## C. LEARNING

### 1. Monitorings carried out

The monitoring plan submitted under the APR 2020 contained monitoring of the DGVPP001 PDP and projects to be implemented in 2021. The DGVPP001 project was cancelled.

For the projects under the DGV01 SGS right after approval of the projects, the monitoring on impacts of the Covid-19 situation and delay in projects implementation related to the delayed start. The monitoring results were that all planned activities within the projects can be implemented by 30 April 2024. However, it was necessary to re-establish the contacts with schools. It was also needed to adjust the time schedule of the projects.

Due to ongoing pandemic of Covid-19 the PO postponed the on-site monitoring of the DGVPP002 to 2022. The main reason was a curfew in most of 2021 and working in regime of home office at the PO, as well as Project Promoter and project partner, which is not appropriate for such kind of monitoring. The attention was therefore given to the regular monitoring through the project interim reports. Within the project interim reports a monitoring on Covid-19 impact was included and meeting of the milestones have been observed. In case of milestones, postponing information about reasons and new plan was required. The first projects under the DGV01 call started their implementation in summer 2021, the monitoring will be carried out in 2022. The monitoring plan is attached.

### 2. Evaluations carried out

Not applicable as the evaluation of the programme has not been carried out yet.

### 3. Lessons learned from monitoring, evaluation and implementation

In 2021 the implementation of the Domestic and Gender-based Violence programme was positively affected by the decision of the Minister of Investments, Regional Development and Informatization of the SR to continue in its original settings. Even though the situation is uncertain, it is needed to work on the Programme implementation and the documents to be ready and flexible to fluently continue with programme implementation, once the situation is changed

or clarified. To be in touch with the DPP, IPO and FMO and to consult the situation at any time and under any conditions (formally/informally) is a basic precondition for effective solution.

The last years' lessons learned are connected mainly with the ongoing Covid-19 pandemic. Since the PO was delimited to the Ministry of Investments, Regional Development and Informatization of the SR, online programme for official approving of documents within the ministry is used that widely simplifies the processes, mainly in period of curfew and home office regimes. The ongoing pandemic has also proved that on-line meetings and events are appropriate, if the situation does not allow to meet or if it is urgent to meet; on the other hand if it is just on-line, the people are replete and it is not so efficient as needed. Long-term situation with only online events is more demanding about creativity; mostly how to attract the people and their attention if they participate. Travel reduction saves time, as well as the environment. However, personal contact is necessary and it is needed to find a balanced way.

The project DGV01009 “*United For Equality*” contracted within DGV01 Small Grant Scheme is specific in the use of various types media and the involvement of a media expert in the implementation of the project. The project activities will employ innovative approaches and methods of awareness raising and education, specifically tailored to the needs of younger generation.

### 2. Best bilateral cooperation examples

The project DGV01004 *Gender Equality Promotion (GEP)* is implemented in cooperation with the Norwegian organization KUN. They also cooperate with Arni Hole – the Norwegian expert in gender equality and gender-based violence. Karin Hovde and Arni Hole participated in the public discussion “Gender equality in Norway: An example for Slovakia?” It was held in hybrid form and shared via Facebook. Until 30 November 2021, it had a range of 6,900 people.

The Launching Conference of the project “Gender Equality Promotion: Slovak and Norwegian Experience” in September 2021 was held in attendance of Norwegian representatives. They responded to the audience questions related to development of women’s right in Norway, paralleled the current situation with the situation in Slovakia, advices what could be improved in Slovakia etc. They participate in regular project meetings.

### 6.b. Results of website and social media activities

Activities on social media in the programme DGBV for the year 2021 were focused on announcements of online information seminars and Call closures and openings. There have been posted Call closure and results of DGV01, Call openings and closures of DGV02, DGV03 and respective ongoing informative seminars throughout the year.
