A. EXECUTIVE SUMMARY

B. PERFORMANCE

1. Programme progress and results

Objectives

In light of the prevalence of violence against women in Slovakia and more than 20 years of women non-governmental organizations (hereinafter referred to as "NGOs") initiatives the violence against women is a well-recognised public issue in Slovakia. As in the previous year, the media paid an increased attention to the situation of women and both various aspects of gender equality and violence against women had been in focus of their attention. As from its establishment in 2015, in 2022 the Coordination-Methodological Centre for the Prevention of Violence against Women (hereinafter referred to as "CMC") continued its operation fuelling the experts' as well as public discussion. Also, in the course of 2022 the business have been increasable more active and supported and/or developed their own initiatives targeting discrimination and violence against women through research and campaigning[1].Several political representatives, including the President of the Slovak Republic publicly addressed the issue of domestic and gender-based violence and the specific needs of women and girls and highlighted the role of women in society on various occasions.

As regards the situation of the NGOs, in spite of the fact that the Ministry of Justice of the SR financially supported the establishment and operation of 8 Intervention Centres for Victims of Domestic Violence in 2022, the financial situation of women NGOs, including those providing specific and vital services to women experiencing violence and their children, remains very unstable. The ongoing uncertainty about future resources to ensure the operation - scope of support provided and activities represents a fundamental obstacle for increasing the availability of specific services. Moreover, capacity building and core costs grants are primarily provided through the European funds. Thus, as in the last decade, the European funds, particularly the Norway Grants, remains important source of contribution to an effort to set up a network of counselling centres and women's shelters in Slovakia. The same applies to the operation of the CMC and the non-stop free of charge helpline for women experiencing violence. In 2022, they are still financed by schemes like European Social Fund or Norway Grants. The National Action Plan on Prevention and Elimination of Gender-Based Violence 2021-2027 scheduled the resolution of their sustainability after 2026.

As regards activities related to promoting gender equality and equal opportunities to women from the human rights perspective, the Norway Grants have been an important donor to fund activities related to this topic.

The Norway Grants thus represents important source of support for prevention, protection and assistance to victims of domestic and gender-based violence in Slovakia.

Outcome 1: Understanding of gender equality increased

Nine projects are being implemented under Outcome 1. All of them are in their full implementation. All of them have already started with the survey focused on gender equality understanding before campaigns held and lectures provided. As the lectures and campaigns are planned through the whole implementation period of the projects, just preliminary results of the baseline value can be presented now. The survey has been conducted by the Project Promoters (hereinafter referred to as "PP") before the implementation of relevant activities (such as lecture or campaign). 68.61% of the population to be targeted by the awareness-raising activities within the projects have been favourable to gender equality and 54.83% have rejected gender stereotyping. 57.20% of the students in targeted schools within the projects have been favourable to gender equality and 54.88% have rejected gender stereotyping. The achieved value are measured after the implementation of the relevant activity by the PPs. The achieved value will be calculated at the end of the projects' implementation, once the all lectures and campaigns are provided or implemented.

The implementation of the survey by the PPs did not run smoothly from the very beginning. Most of the PPs are small, non-governmental organisations and have challenged their obligation to run surveys that had to be done in order to



establish the baselines of the outcome's indicators. The NGOs informed the Programme Operator (hereinafter referred to as "PO") that they have neither capacity nor they possess sufficient expert knowledge to run and evaluate such surveys. The PPs claimed that they would have to employ professional market research agencies and asked whether not running the survey would mean the cancellation of the Project Contract.

As it can be seen from the preliminary results, in the end the efforts to enforce the fulfilment of the task by the Project Promoters has been successful. However, seeing this issue from a broader perspective, the objection of the PPs that such surveys shall be run by and evaluated by skilled professional, so as not to lose its probative value, should be considered relevant. The PO agrees with the objection of the PPs and for the future recommends running such survey by the Financial Mechanism Office for all the Programmes relevant.

Nine institutions active in the field of gender equality (MyMamy, OZ Žena v tiesni, EsFEM, Institute of Human Rights, InTYMYta, Risoto, Slovak national centre for human rights, Freedom of Choice, Union of Maternity centres) are directly supported in the Programme as a PP or project partner. If we took into account also the organizations, which are benefitting from the projects through the conferences or other events, in that case the achieved number would be 20. The number would be even higher, if we took into account the organizations about which the project DGV01010 informs on its webpage. Therefore, the actual value of the indicator *Number of institutions active in the field of gender equality supported* (target value 12) depends on the point of view.

So far, 17 awareness-raising campaigns promoting gender equality have been held (the Programme's target value is 15). Most of the campaigns are connected with the period of 16 days of activism against domestic and gender based violence at the end of the year.

The various PPs organize the campaigns on the same topic, but in various ways. It means all of them are different and interesting. The project DGV01003 of MyMamy organizes festival FemFest, the main theme of which is the status of women in society. The content of the festival in 2022 was a discussion on the topic of Women in regional politics accompanied with screening of the movies and a concert of Dorota Nvotová. Before each of these events, a short video shot on the topic of gender equality in our society was shown, and the PR manager informed about the context of FemFest, the reasons and the need to organize such events in the east of Slovakia.

The project DGV01005 implements many activities in 4 MRCs. They organize small appropriate awareness- campaigns for women from MRCs on the occasion of the International Day of Women and Roma Day. The organized workshops were dedicated to the topic of the important Roma women.

Two public discussions were carried out in the DGV01006 project. The topics are chosen with regard to the interest declared by the participants. In both cases, the participation exceeded the PP's expectations. It turns out that the issue of co-dependency and toxic relationships in the context of gender stereotypes is a topic that continues to be one that the public perceives as necessary to discuss.

So far the lectures specifically focused on gender equality have been provided in 58 schools (target value 89) in 25 districts. 13 of them are schools with MRCs (target value 30). The lectures are planned through the whole projects' implementation; the target value of these indicators thus can be met. Based on the projects applications provision of the lectures in 157 schools (72 in MRCs) are expected. At the programme level, it is difficult to say if the indicators will be achieved or not, as some schools are involved in more projects. At the programme level, every school is counted just once.

Outcome 2: Victims of domestic and gender-based violence protected and supported

In 2022, the selection process of the calls DGV02 and DGV03 was finished. The project contracts for all projects approved were concluded.

Under the DGV02 call focused on support of existing services and local intervention teams there have been 7 projects, including one from the reserve list. At the end of 2022, one of the PPs decided not to implement the project. It was the project DGV02016 and the reason is that the PP has been provided with other financial sources, thus the grant have become superfluous. The division of the funds through the sources would mean an administrative burden for such a small organization. The PP also found the publicity requirements to be too demanding for the organizations in the area of domestic violence with limited personal capacity.



Only 9 existing counselling centres, compared with target value 35, are being supported. The similar situation is with the existing places in women's shelters – 85 to be supported in comparison with the target value 200. The expectations of the Programme were too ambitious. To support the services in targeted values would mean that almost all services available in Slovakia would be supported in the Programme, which has proven to be unrealistic. As the calls on services in DGV were postponed and their launching was in the course of COVID-19 pandemic, it affected the prices and the project grants applied for were higher than expected during the Programme Concept Note preparation. The area of DGV is very sensitive and financially and capacity undersized. This was evident during the calls, in which not many applications were submitted and except for one project application, all submitted applications were approved. The funds initially allocated to the calls were not committed and have been reallocated or are going to be reallocated.

On the other hand, all the key players in the DGV area are supported within the Programme, which means that the Norway Grants are considered trusted, reliable and beneficial source of support for the well-known active organizations in the area.

All the projects already started their implementation by providing the counselling services to victims of violence in May/June 2022. So far, 283 beneficiaries (target value 700) have been provided with the services. Based on the PPs' expectations the target value will be overachieved. This target will be overachieved even though the target values of the indicators Number of existing counselling centres supported and Number of existing places in shelters supported are not going to be met. The awareness-raising and educational campaigns are being prepared and the target value (10) will be overachieved based on the PPs' plans, as well.

Under the DGV03 call, all three submitted project applications were approved and the project contracts concluded in autumn 2022. The new counselling centres to be established or specialised to meet the required standards are not going to be supported only under this call, but also the existing organizations are going to spread their services by establishing the new counselling centres as their branches in new locations. A good example is the project DGV02013 as a joint project of the NGOs - services providers in Košice Self-governing Region – Fenestra Košice, OZ Hana Spišská Nová Ves and Help to Family Michalovce. Altogether 7 new counselling centres are going to be established (target value 15) and 15 new places established of the women's shelters (target value 50).

Together 12 counselling centres and women shelters meeting the European standards are involved in the projects. At the end of Programme implementation 8 more counselling centres should meet the European standards.

The target values of the indicators Number of shelters and counselling centres enhanced in terms of children needs (43) and Number of services providers running or participating in a consortium with public institutions at local level (43) will not be achieved due to reasons already mentioned. However, all the counselling centres and women's shelters involved in the Programme are working on their enhancement in terms of children needs.

Outcome 3: Response systems to victims of domestic and gender-based violence improved

Under outcome 3 the predefined project of the Institute for Labour and Family Research "Improving the victim-oriented approach – a tool enhancing the capacity to fight violence against women and domestic violence" is in full implementation from 2022.

7 regional coordination and methodological teams were established and are operating in 7 Self-governing Regions in Slovakia. For all the regions, the regional action plans have been elaborated and published.

So far 32 out of 47 planned lectures and consultations were provided to supporting professions. At the end of 2022, 6 training modules for Centres for Children and Family in the field of prevention and intervention in cases of sexual abuse were implemented. More than 1 850 participants took part. The on-line education Crisis intervention on the topic of violence against women was attended by 11 people; Profile of the perpetrator of violence against women by 13 people, Counselling for homeless women experiencing violence in partner relationships by 39 persons. Face-to-face training on the topic of Selected aspects of the investigation of sexual offenses committed against women and children was also carried out with 12 participants from the Police Force. At the same time, a specialized course for domestic violence investigators was completed, and on October 12, 2022, the course was accredited by the Ministry of the Interior of the Slovak Republic. The total number of professional staff trained is 1 933.

10 specialised police teams will be created after completing a specialized course for investigators in the field of domestic violence conducted by the Academy of Police Force in the SR. In the course of 2023, at least two specialized investigators will be working in the district units of the Police Force investigating violent crimes.

8 rooms in police stations are going to be customized to the needs of victims of domestic and gender-based violence in 2023.

The research activities continue with the Norwegian partner in the area of the situation of women and children who live in women's shelters. Each of the partners prepares a research part at the national level. Based on the results the standards for institutions active in the field of DGV will be elaborated and put in place. An in-depth analysis is also going to be carried out in 2023.

Based on the survey conducted by the PP the baseline value of the indicator Level of satisfaction of institutions and organisations involved in the response systems with the effectiveness of the response system is 6 and at the end of project implementation the level 8 is expected.

Despite the enormous effort of all the involved, the predefined project of creation of the Sexual Assault Centre in Bratislava has been unfortunately cancelled due to national difficulties and limited time for implementation. The funds allocated to the Project in amount of 1 200 000 euro have been proposed to be reallocated from the Programme. The Programme modification proposal will be submitted to the donors in 2023.

Bilateral Outcome: Enhanced collaboration between beneficiary and donor state entities involved in the programme

After closing all calls, there are only 3 projects implemented in cooperation with a Norwegian partner – predefined project DGVPP002 and two projects focused on gender equality – DGV01004 and DGV01010.

The partnership of the CMC within the predefined project with the Norwegian Centre for Violence and Traumatic Stress Studies started in 2015 and currently focuses on research activities. In addition to exchanging experience and knowledge, both partners are implementing the joint research project on support services for women experiencing violence with results relevant to both countries. A wider impact of the partnership on strategies and professional procedures for the protection of women experiencing violence and their children are therefore assumed.

In the project DGV01004 Gender Equality Promotion (GEP) there is the Norwegian partner KUN involved. The main activity of the project is public campaign focused on fight against disinformation on gender equality. The experts of the partner organization, Arni Hole and Karin Hovde, provided consultations for the two-stage campaign. Now they consult the material for the public campaign in the form of feedback to texts, content and influencers. The transfer of know-how from Norwegian partner is connected with the Norwegian situation – defining how gender equality is anchored in Norway today and what progress has been achieved in the areas of family/work life balance. The Norwegian partner also provides consultancy on the content of workshops for youth, advising on what worked/what did not work in working with youth according to their experience.

In DGV01010 project 34all (three for all) - "Three substantial messages on comprehensive sexuality education and sexual and reproductive health and rights for each target group" the Norwegian organization Sex og Politikk is involved. The Norwegian partner provided the PP with the best practice related to Pink Competency offering academic help and education regarding gender and sexual diversity, Uke6 – the practice of the methodological week on comprehensive sexuality education and Sex og Samfunn - practice of the youth clinic in Oslo regarding services, education and impact of activities.

In the project DGV03019 the Norwegian organization Alternative to Violence is a cooperating organization. The PP has agreed on non-formal cooperation with the Alternative for Violence, which is an organization with 15 offices located all around Norway and have been working in the field since 1987. Alternative to Violence will assist in preparation of courses and help with a transfer of know how particularly focusing on children in violent relations. For the education purposes, a documentary movie will be produced by the PP Alliance of women in Slovakia, which is already experienced in the documentary production. The movie will be designed after a consultation with the Norwegian Alternative to Violence and shall particularly focus on the situation of children in violent parent's families.

In 2022, the PO participated in two conferences for SYNERGY Network against Gender-based and Domestic Violence members, which were organised and partially funded by the Council of Europe, the International Partner Organization



(hereinafter referred to as "IPO"). On 10 March, the international conference Digital Dimension of Violence against Women was held, organised together with the Active Citizen's Funds of Greece and Cyprus. On 30 March, a second conference of SYNERGY Network was held to respond to urgent emerging needs from Ukraine, the SYNERGY Conference on the protection of asylum seeking, migrant and refugee women and girls. In addition, a Study visit was held in Strasbourg in November 2022 to raise awareness regarding violence against Roma women. The Slovak Republic plans to host a SYNERGY conference and meeting in December 2023, which will involve the CoE in planning and implementation.

In December 2022, the bilateral call DGVBF04 on strengthening the bilateral relations between Norway and Slovakia through activities such as networking, exchanges, sharing and transfer of knowledge, technology, experience and best practice between the Slovakian and Norwegian entities active in the field of domestic and gender-based violence was launched. The allocation is 95 126.95 euro.

The Programme also contributes to strengthening of bilateral relations between the donor and beneficiary countries by the excellent cooperation with the Helsedirektoratet - the Donor Programme Partner (hereinafter referred to as "DPP"), IPO, CMC, PO and the Ministry of Labour, Social Affairs and Family of the SR (the members of the Cooperation Committee). In 2022, the DPP and IPO provided advice and reflections in selection procedures and in the Cooperation Committee's meetings; monitored the progress in the Programme and provided strategic advice on domestic and gender-based violence and support to the Programme. The DPP followed-up of the collaboration between the Norwegian partner and CMC, engaged a Norwegian partner in the planned pre-defined project of Sexual Assault Centre in Slovakia and facilitated contacts towards World Health Organization, preparing their contributions. The IPO provided direct support to the PDP of CMC by providing translation into Slovak for an online HELP course on Women's Access to Justice, to support training initiatives under PDP for lawyers, prosecutors, Ministry of Justice of the SR employees and the judicial academy. Further, the IPO shared opportunities for additional funding of Slovakia's women's rights NGOs with the PO and the Cooperation Committee members and provided translations into Slovak of key Council of Europe guidance documents on the rights of displaced women and girls.

C. MONITORING AND EVALUATION

1. Monitorings carried out

In 2022 in addition to the review of Projects Interim Reports reviewing the progress of the project every 4 months, including the phone and e-mails communication with the PPs, regular monitoring, including site visits were carried out. The risk monitoring on the predefined project was carried out because of delay in the implementation and low spending and 6 results monitoring of the projects focused on gender equality – DGV01003, DGV01004, DGV01005, DGV01006, DGV01008 and DGV01009. The monitoring reports are going to be completed at the beginning of 2023.

Due to personnel changes at the end of 2022 the other regular monitoring planned were postponed to 2023.

The projects on gender equality are being implemented in slight delay; however, there are no doubts about their successful implementations by the end of eligibility period.

The predefined project has struggled with public procurement issues at the ministries involved and the delay has been much more appreciable. The project will also be a subject to the PO's regular monitoring, including site visit in 2023.

The regular monitoring on the rest of the projects is planned for 2023. It will be mainly the results monitoring and for some projects compliance monitoring.

2. Evaluations carried out

The evaluation is not planned in the programme, as it will be carried out by the National Focal Point.

Annex 2: Communication summary

1. Best projects

The project DGV01004 Gender Equality Promotion (GEP) of the civic association Human Rights Institute is one of the best practice example. The project aims at the condition of successful gender equality, which is conditioned by the support of the surrounding society. Therefore, the project focuses on sensitizing and educating people about gender equality and thus increasing its public support. The project includes three different types of activities, such as breaking down the most common myths related to gender equality, an online campaign in the form of videos on various topics related to gender equality and educational workshops in secondary schools. A great asset of the project is the consultation and transfer of know-how by experts from the Norwegian partner organization KUN - Centre for Equality and Diversity.

The project DGV01005 GENDER EQUALITY for ROMA COMMUNITY (GER) of the organization People in Need is considered very important as it directly focuses on women from marginalized Roma communities in questions of gender equality. Its aim is to raise awareness of gender equality and empower women in four marginalized Roma communities (hereinafter referred to as "MRC"). There are educational activities, campaigns - dissemination activities, and strengthening activities to support girls and women in MRC implemented. The activities are based on the real needs of Roma girls and women formulated by their "own voice". The unifying lines of the project are the visibility of (Roma) women, the development of friendship among women, and the breaking of stereotypes (especially stereotypes in connection with the myth of parenthood as motherhood, female friendship/enmity, religious faith as a barrier of gender equality and others). Project outputs are min. of 20 workshops in cooperation with primary and secondary schools, 4 workshops in the community, a wall calendar dedicated to the topic of prominent Roma women, a quartet representing prominent women - women activists ("women without borders" and "Saints as we do not know them"), as well as an exhibition of works by Roma children.

2. Visibility of the Grants and the Donors

2.a. Communication activities

The PO proceeds in line with the Communication plan for the programme. The PO communicates its dissemination and publicity activities with Royal Norwegian Embassy to Slovakia and the Press Department of the Ministry of Investments, Regional Development and Informatization of the Slovak Republic. Through the web site <u>www.eeagrants.sk</u> and Facebook profile <u>https://www.facebook.com/EEANorwayGrants/</u> the PO communicates with general public and besides the basic information presents the programme activities and results. Information about the programme and projects implemented are published.

The Domestic and Gender-based Violence Programme webpage <u>www.norwaygrants.sk/dgv</u> is a subpage of the national single web page operated in Slovak and English. Within this page, 3 articles were directly dedicated to this programme in 2022. Two news were dedicated to the Call closure within DGV02 and DGV03; the latest news was the announcement of the DGVBF04 call.

2.b. Project stories



Activities on social media, precisely the Facebook page, in the programme DGV for the year 2022 focused on presenting individual projects, announcing their conferences, seminars and another online or in-person events. One of the most visible activities within this programme was connected to the 16 Days of Activism against Gender-Based Violence, presented in four posts. The latest post announced in the year 2022 was the Call opening (DGVBF04) for the grant application submitted under the Bilateral Fund to strengthen bilateral relations between entities from Norway and Slovakia. Overall, the programme DGV has earned on Facebook a number of posts (15), likes (47), and shares (1) and had a significant reach of posts (3257) to individuals. The post with the most likes (8) was a video from the project - We Build Bridges for Help (DGV02022) related to the 16 Days of Activism against Gender-Based Violence, which aimed to raise awareness about domestic violence. This particular project is one of those that focus on activities that provide quality specialized counselling services to victims of violence.
