1 BACKGROUND

This document has been prepared to reflect the period of the year 2024 and 2025.

1.1 Major fields of bilateral cooperation between Slovakia (“SK”) and Donor States (“DS”)

The bilateral relations between Slovakia and the Donor States (Norway, Iceland and Liechtenstein), from a long-term perspective, can be generally characterized as **very good, friendly and effective, with a strong potential for further cooperation and development**. The level of bilateral relations between Slovakia and the Donor States (especially with Norway) is also clearly reflected in the relatively high number of common events, meetings and other interesting bilateral activities.

Cooperation between SK and the DS takes place e.g. at political level, in business and investment, education, science and research, culture, energy, innovation, social issues, as well as in the context of cooperation within international organizations.

1.2 Short evaluation of existing bilateral relations and their development (based on 5 crucial areas of interest)

As regards **political and institutional¹ cooperation**, there is a strong cooperation at diplomatic level between **Norway** and Slovakia², documented through the number of official visits, including a visit of the Vice Prime Minister in Oslo in November 2022 or the visit of Minister of the Environment of the Slovak Republic in May 2024. Important contacts and forms of cooperation have been established that can be further developed. Cooperation with **Iceland** is moderate, the highlight of this cooperation being the state visit of the Icelandic President in October 2022. Slovakia and **Liechtenstein** established diplomatic relations in 2009 and since then cooperation has been steadily increasing at bilateral, EEA and UN level (within international organisations). This has been illustrated, i.a., by regular visits at Ministerial level and bilateral exchanges in the margins of international conferences.

In the **economic area** investments and trade from **Norway** to Slovakia are moderate, with some larger investments made over the past years, and with a potential for further development. Economic relations

between Slovakia and Liechtenstein are increasingly close. Investments from **Iceland**³ can be considered as low, with potential for further development. Investments from Slovakia to all the three Donor countries are negligible.

In the **cultural area**, close cooperation has been developed between different Slovak and **Norwegian** institutions and artists. **Iceland** is a very interesting destination for artists from all around the world, including Slovakia, and cultural relations between the two countries have the potential to develop. Some cultural cooperation has taken place with **Liechtenstein**, but there is also some potential for development. This field of cooperation was the most attractive area under the Bilateral Fund in the previous programming period.

As indicated before, **historical ties between** Slovakia and the Donor States are, for objective reasons, considered low. **Norway** is an exception to this, with the legacy of Bjørnstjerne Bjørnson being still vivid in Slovakia. The same applies to the **general knowledge and public awareness** of Slovak citizens about Norway, where **Norway** is perceived as a role model country of how things may work in the society.

People-to-people contacts (such as students, visitors, employees) are most frequent between Slovakia and **Norway**. There is also a big community of **Norwegian** students in Slovakia (at the end 2022 almost 500) studying medicine and veterinary medicine, and the number of **Icelandic** students has been increasing. There is also a growing community of Slovaks working in **Norway**, especially in the healthcare and transport sectors.

1.3 Experiences / lessons learned and successes from FMs 09-14

In the programming period 09-14, funds of the Bilateral Fund were distributed through open calls, predefined activities, as well as activities implemented directly by the NFP/PO. The experience from the past period shows that:

- Support to larger-scale activities with a clear focus on a particular field of cooperation brought more sustainable and higher quality results.
- Larger-scale activities brought more opportunities the promotion of partnerships, media coverage, better communication measures as well as wider presentation of the respective activity and bilateral dimension generally.

There are several examples of bilateral activities which can be considered as **success stories**:

- **strategic contribution of EEA and Norway Grants** under the EU Slovak Presidency 2016, e.g. in the areas as green economy and energy (in particular flagship conferences on transition to green economy and energy security);
- **bilateral activities implemented by academic institutions** – e.g. a series of cultural bilateral activities implemented by the Academy of Performing Arts in Bratislava in cooperation with the University of Bergen (International Grieg Society) or the predefined activity implemented by the University of Veterinary Medicine and Pharmacy in Košice in close cooperation with Nord University in Bodø and close cooperation of the Jessenius Faculty of Medicine in Martin of the Comenius University in Bratislava and Bjorknes College.

The setup and the implementation of the Bilateral Funds in Slovakia under the FMs 09-14 have been very successful and the Bilateral Fund at National Level could be regarded as a model for programming period 14-21 also for other Beneficiary states.

A more **targeted approach** within selected fields of cooperation can bring more visible results. **Visibility of results** in close connection with **high level of quality** of results should be the overall ambitions of the implementation of the Bilateral Fund in this period.

The fund shall support well-balanced partnerships (bilateral or multilateral) where all parties benefit from the cooperation.

1.4 Upcoming activities / initiatives

In the upcoming period, there will be several **opportunities**, in the framework of which strategic initiatives can be funded by the Bilateral Fund mainly through predefined initiatives and an open call (FBR03) included in this Work Plan that are to be implemented in 2024-2025.

1.5 Possible ways for promotion and partnership facilitation under Programmes

In the Memoranda of Understanding, €600,000 (11,22% of the Bilateral Fund allocation) has already been set aside to the Programmes. Partnerships between SK and DS entities shall be promoted and facilitated through already well-established measures such as matchmaking events or study visits that were also supported by the Bilateral Fund at the Programme level in the 09-14 period, for which the baselines and suggestions for how to achieve them already exist.

In addition to this, the following initiative was proposed by the Programme Operator:

- 1) Bilateral workshops focused on the role of cultural players in arts and culture under the Culture Programme.

2 MAIN OBJECTIVE

The main objective has been defined as: “Enhanced cooperation and improved mutual knowledge and understanding between Donor and Beneficiary States”.

2.1 The main ambitions

The **main ambitions** of the Bilateral Fund are closely linked to Chapter 1 of this document.

It is proposed that in **2024 and 2025, the Bilateral Fund will continue supporting political and institutional cooperation** between Slovakia and Norway, Iceland and Liechtenstein as well as **cultural cooperation** – cultural exchange, promotion of culture and cultural development in Slovakia and Iceland / Liechtenstein / Norway.

2.2 Implementation system – general principles / modalities

The first meeting of the Joint Committee for Bilateral Funds (JCBF) took place on 27 October 2017 in Bratislava, Slovakia. The JCBF is chaired by the National Focal Point and composed of five members, including the NFP, the Ministry of Foreign and European Affairs of the Slovak Republic, the Norwegian Ministry of Foreign Affairs, represented by the Royal Norwegian Embassy in Vienna, the Icelandic Ministry of Foreign Affairs and the Ministry of Foreign Affairs of the Principality of Liechtenstein.

In the first meeting, the JCBF adopted the Statutes and Rules of Procedures and gathered inputs to the Work Plan for the bilateral funds.

On 15 December 2022, the twelfth meeting of the JCBF took place and it was agreed, that the potential of the selected priority areas was not fully utilised. The implementation of the Fund in 2020-2022 was heavily affected by the COVID-19 pandemic. The members have therefore agreed that the political and institutional, as well as cultural cooperation will be prioritized also in 2023-2024. In 2023-2024, the thirteenth – twentieth⁴ JCBF - meetings of the JCFB were realized in form on per-rollam meetings.

Mechanisms to ensure flexible funding and the principle of proportionality will be applied at all levels.

2.3 Allocation

The total allocation of the Bilateral Fund is **€5,349,023**⁵. Among the total allocation, based on MoUs, the amount of €600,000 has been set aside to Programmes. This allocation is not subject to any further approval by the JCBF or NFP.

Within this version of the Work Plan, the NFP focuses on the distribution of funds in the year 2024 and 2025, **division of allocations is specified in Part 6 – Budget.**

The NFP may propose additional suggestions for the use of potential savings as well as currently unallocated funds (subject the approval of the JCBF), or they might be transferred to the 2025 period.

2.4 Principles of selection and assessment

Selection of Grant Applications follows these basic rules:

1. All members of the JCBF shall have an opportunity to vote on every Grant Application.
2. For a Grant Application to be supported under an open call, a quorum must be reached (3 out of 5 of the members must vote). In case of travel grants, silent procedure shall be applied.
3. If any of the members vote against a Grant Application, such application shall not be supported. This should, however, be proceeded by a discussion in an effort to reach the consensus of all the members.
4. Any member may propose modifications to the Grant Application. In case that substantial modification is proposed, the application needs to be re-evaluated.
5. Any member may enter scrutiny reservation. It is possible to use this procedure also to request more information from the applicant. Scrutiny reservation is not applied under travel grants.

Under specific circumstances, the National Focal Point may directly approach Ministries and other “umbrella” organizations to submit their proposals for bilateral initiatives.

More detailed rules are included in Annex I to this Work Plan - Rules for awarding grants.

3.1 Applicants and financing

Eligible applicants / partners are legal persons registered in the Slovak Republic or in the DS.

The minimum grant amount for an activity / initiative supported through the call will be stated in the particular call.

Generally, payments are provided as reimbursement of already incurred costs. If the grant amount exceeds €25,000; an advance payment of up to 80 % may be provided by the NFP following the signature of the contract.

3.2 Modalities for allocating of the funds

Strategic focus on ministries or other “umbrella” organizations

In order to strengthen the systematic and strategic focus of the Fund for Bilateral Relations at the national level, the NFP approached line ministries and other “umbrella” organizations to submit their proposal for bilateral initiatives.

Regarding the financial limits, the minimum contribution for one predefined bilateral initiative was set to €20,000; the maximum contribution for one predefined bilateral initiative was set to €75,000; with a maximum duration of 12 months.

The proposed initiatives must be implemented in close cooperation with the relevant institution in the donors’ states. The plan to directly approach ministries and other “umbrella” organizations has shown to be effective. The NFP is of the opinion that this approach has proved to be effective as there were 19 applications received and 10 new predefined activities have been contracted in 2023. Also, the NFP launched a new Open Call (FBR03) in 2024.

The priorities of pre-defined activities / initiatives for 2024 - 2025 will be focused on *political cooperation and cultural cooperation*. Other predefined activities proposals can be discussed within JCBF in accordance with Statutes and Rules of Procedure of the JCBF. In case a member of the JCBF shall implement a pre-defined activity upon the approval of the JCBF, the respective member shall abstain from voting.

Any uncommitted funds from the open call may be allocated for the call for smaller scale activities and vice versa, subject the approval of the JCBF.

5.5 Predefined initiative 5 - completed

Reducing the Gender Pay Gap

Implementing entity: Ministry of Labour, Social Affairs and Family of SR

Partner(s): The Directorate of Equality

Allocation: €15 000

Disbursed amount: € 11 456,33

Short description:

The gender pay gap in Slovakia has long been above the average for the EU level even though it continues to show a favourable falling trend. Gender segregation in the labour market in Slovakia is closely linked to the overall lower income of women. Despite women's excellent level of education women do not achieve comparable earnings to men because education in "typically female areas" is less valued. The current control mechanisms under Labour Inspection need a new impulse to reinforce the existing legislation better.

Iceland could be used as a good example since its policies belong to the most progressive in the world. The law on Equal Pay Certification entered into force in January of 2018, by additions to provisions of the Icelandic Gender Equality Act. The immediate effect was a requirement that all ministries and workplaces with 250 or more staff members on an annual basis are supposed to obtain Equal Pay Certification by the end of the year 2018. With minor adjustments to original aims, this has meant that practical application and knowledge about implementing the gender pay standards has been acquired in numerous organisations.

Building on this experience, the Directorate of Equality in Iceland will provide a workshop for delegates from Slovakia followed by a study trip. In the workshop, the history of gender equality and equal pay legislation will provide a backdrop for the analysis and presentation of the most recent developments in gender pay legislation. The workshop, to be held in Iceland, will include presentations from specialist advisors and lawyers mandated the administration and implementation of the Icelandic Gender Equality Act. Accredited auditors from licensed auditing bodies will provide insight into the certification of the equal pay management system. In addition, corporate human resource experts will give examples of the benefits of working within the framework of the equal pay system.

More Human Approach into Human Rights Education in Slovakia

Implementing entity: Open Society Foundation / NOS-OSF

Partner(s): University of Southeast Norway, Drammen, USN

Allocation: €45,000

Disbursed amount: € 34 688,34

Short description:

Insufficient level and quality of Human Rights Education (HRE) in Slovakia creates a number of challenges. Education in this area is often reduced to simply memorizing facts and definitions, teaching history without references to other topics. That is why the focus of the initiative will be on the preparation of future pedagogues in Slovakia. The initiative will use the inspiration from University of Southeast Norway in Drammen where the Human rights Education is the *red line through the whole curricula* of the future pedagogues and incorporate them into preparation of the curricula of Slovak teachers and more specifically on their human rights related competences.

The Initiative would like to develop the design of a course on Human Rights education for Topics as: Rights of a Child, Participation, Climate Change, Migration, Feminism, Holocaust and others. In addition, the initiative will focus on influencing the attitudes of target groups towards minorities.

The initiative would start in the August 2022 and will finish in August 2023. It would prepare and realize a pilot course on Human Rights Education at the faculty of Education in Bratislava for students, with the inspiration, help and presence from the partners from University in Drammen. The proposed activities will focus on mapping and comparison of the existing methods in both Universities, joint preparation of the course, study visits, realisation of the workshops during the course, evaluation of the outcomes from the workshops and communication activities.

The Grant Application, including a detailed proposal for the bilateral activity and related description and indicators will be subject to discussion in the JCBF. Following the conclusion of the discussion about the Grant Application in the JCBF, the information listed in the Work Plan will be updated accordingly.

Bilateral cooperation in the area of asylum and migration

Implementing entity: Migration Office of the Ministry of Interior of the Slovak Republic

Partner(s): The Norwegian Directorate of Immigration – TBC

- **Possible partners from Iceland and Liechtenstein - TBC**

Allocation: € 500 000 - TBC⁸

Short description:

The main ambition of the Initiative is to respond to the current situation in Ukraine and the exchange of information between Slovakia and Norway in the area of asylum and migration. The Initiative has two main components:

1. Enhancement of conditions of asylum seekers in the asylum camps, including the help to asylum seekers to exercise basic rights.
2. Enhancement of services provided to migrants through transfer of know-how from Norway.

By implementing this initiative, Slovakia responds to the war in Ukraine, Slovakia's eastern neighbour. Slovakia has not faced such an influx of asylum seekers in the past, and the experience from Norway might help to established procedures safeguarding the basic rights of asylum seekers. Special attention shall be paid to women with children, mostly in the asylum camp in Opatovská Nová Ves. This camp has the capacity of 140 people and predominantly serves for vulnerable groups such as mothers with children etc. Smaller-scale restoration works are envisaged that will turn the gym into a multifunctional space, able to serve as emergency accommodation and thus increasing and improving the capacity of the facility. Purchase of IT equipment enabling using the internet services is also planned, including other equipment and materials, as necessary. This activity should not exceed EUR 150,000. Special attention shall be paid to the needs of children, incl. their educational process.

Through this Initiative, Slovakia also recognises that lawful and desirable migration is essential for the economic development of Slovakia. The Slovak Migration Policy until 2025, recently adopted by the Slovak Government, consider the establishment of an environment attractive for foreigners essential in the global competition for qualified workforce. A user-friendly migration and asylum system is a necessary precondition for the potential of Slovakia to attract foreign talents. Experience from Norway may help Slovakia in achieving this objective. Secondments, study trips and trainings are expected to take place under this activity. At the Slovak side, the imminent interest is to visit the Norwegian integration centres. The relevant Slovak stakeholders, including the staff from the Migration Office of the Ministry of Interior, the Ministry of Labour, Social Affairs and Family, Bureau of Border and Foreign Police of the Ministry of Interior, and Slovak Humanitarian Council shall be invited to participate in this activity. Certified training courses led by Norwegian experts are also welcomed.

It is proposed that the Project be implemented in cooperation with **the Norwegian Directorate of Immigration (UDI)**, the counterpart of the Slovak Migration Office. The UDI is the central agency in the Norwegian immigration administration. The UDI implements and helps to develop the government's

immigration and refugee policy. In this initiative, UDI will help the Slovak Migration Office with facilitating lawful and desirable immigration and ensuring that those who meet the requirements are given an opportunity to come to Slovakia. At the same time, UDI will share its experience with measure preventing abuse of the system.

Short description:

Tackling global and climate change requires a holistic approach that integrates various scientific disciplines and involves different stakeholders and target groups. The proposed third joint scientific conference "The impact of global change on the environment, human and animal health" is a highly multidisciplinary platform intended for researchers, PhD students, students and professionals to share the latest knowledge in this field likely to result in advancements that could benefit the societies in Slovakia, Norway and globally. Speakers from Slovakia, Norway and other countries will give lectures under 3 main sections: 1) Impact of global and climate changes on the environment, 2) Impact of global change on public and animal health, and 3) Effects of global and climate change on water resources and air. Representatives of Slovak and Norwegian policy-making and/or regulatory bodies will be invited as committee members and/or conference attendees.

The University of Veterinary Medicine and Pharmacy in Košice (UVMP) and Nord's Faculty of Biosciences and Aquaculture (Nord, FBA) have successfully cooperated in education and research for over a decade. Expanding on this existing bond, UVMP and Nord, FBA organised the first joint international conference on global change in Košice in 2017. The success of the conference convinced the organisers to make it a biennial event. Another joint conference (NordGlobal 2019) was held in Bodø, Norway, in May 2019. The third conference was originally planned for May 2021 in Košice, however, due to the global pandemic, it was postponed until the pandemic recedes. Preparatory activities for the third conference will start in December 2022. The conference is planned to take place in May 2023 in Košice.

Green by Iceland invited SARIO to organise an expert study visit to Iceland as part of the deepening dialogue in terms of geothermal and renewable energy sources together with focus on their sustainable exploitation. As part of the study visit, H.E. President Gudni Th. Jóhannesson will be visited to debate further the possibilities for future bilateral cooperation on geothermal and renewable energy with the Slovak delegation members. The study visit will include field trips to respective power plants producing heating and electricity from geothermal and water sources. As a part of the agenda a workshop/business forum will be organised intended to create direct contacts among Slovak and Icelandic entrepreneurs, relevant research entities and institutions and non-governmental bodies such as municipalities, and universities, clusters and NGOs active in field of renewable energy production and sustainable transition. The workshop will provide space for presenting Slovak intentions and potential in renewable energy development and projects in which Icelandic knowledge can be effectively implemented. Apart from the field trips and workshop, a few cleantech venue-visits will be organised to demonstrate other available possibilities for sustainable resources exploitation such as waste recycling, CO2 capture and storage, health, agriculture etc.

5.21 Predefined initiative 21

Name of the initiative: Promotion and strengthening of the Slovak-Norwegian cooperation in the preventative care of cultural monuments

Implementing entity: Slovak Monuments Boards

Partners: Riksantikvaeren, Norsk Kulturvarv and National Trust of Norway

Allocation: €500 000

Short description:

The pre-defined bilateral initiative will further expand the bilateral dimension of the two pre-defined projects in this programming period - Pro Monumenta II & Red Monastery – Reborn under the ‘Culture’ programme. The initiative will provide a comprehensive framework for bilateral cooperation between the Slovak and Norwegian Monuments Boards, including:

- joint restoration of a small monument over several months (monk’s house) at the premises of the Slovak Monuments Board, to map in detail the practices of monument restoration in Slovakia and Norway,
- raising awareness of the need for preventive maintenance of monuments through a media campaign in Slovakia and Norway, so as to keep the idea of preventive maintenance of monuments in the public discourse as an important method for the protection of cultural heritage in both countries,
- joint works on a platform that would lead to the development of a widely available mobile application providing advice on preventive maintenance of monuments,
- transfer of experience with the established model of preventive maintenance of monuments by Slovak and Norwegian experts in other interested EEA countries (for example, Romania has already expressed its interest in the initiative),
- joint study tours of monuments restored in the recent past in the Czech Republic,
- international conference on preventive maintenance systems in selected EEA countries, to present the concept and results of the introduction of the preventive maintenance system,
- evaluation of the Pro Monumenta concept, to evaluate the effectiveness and impact of preventive maintenance in protecting cultural heritage, including recommendations for bilateral and multilateral cooperation.

Expected period of the implementation is in 2024-2025.

Name of the initiative: Bilateral cooperation in the field of public procurement

Implementing entity: Public Procurement Office Slovakia

Partners: The Norwegian Agency for Public and Financial Management (DFØ),
The Board of Appeal for public procurement

Allocation: €30 000

Short description:

The aim of our bilateral activities is to strengthen relations and cooperation, establish a partnership and exchange of experience in the field of public procurement with a focus on the strategic public procurement, quality as award criterion, review procedures, centralization and the use of contract management in the field of public procurement. Considering the agenda, the main goal we would like to achieve is the exchange of good practices to support the development of the public procurement.

This project should achieve the formation of an international partnership and an effective exchange of information between partners from Norway, focusing on the field of development of the public procurement.

We plan to achieve the goal of the project through foreign work trips to Norwegian partners as well as a round table meeting at the Public Procurement Office in Slovakia.

This cooperation is planned as long-term not only for this initiative, supported by online, as well as, personal meetings, study trips, etc. In addition to the above, it is clear that it will contribute to the creation of an effective communication channel between the PPO and Norwegian partners.

Name of the initiative: Study Visit to Explore Data Management and Innovation Practices in Norway

Implementing entity: Ministry of Investments, Regional Development and Informatization of the SR

Partners: The Norwegian Association of Local and Regional Authorities (KS)

Allocation: €26 150 (+possibly savings from FBR03 Open Call, if needed).

Short description:

The proposed study visit to Norway is a predefined initiative of the NFP which aims to explore the innovative practices of KS in local governance, data management, and innovation. We are particularly interested in understanding the KOSTRA analytical platform, including its key features, development process, and methodologies for data standardization and quality assurance. Additionally, we seek to learn about the strategies and incentives used to engage municipalities in data sharing and integration. Another focus of our visit will be the operation, objectives, and innovations supported by KS's living labs and testbeds, examining how these platforms facilitate real-time data utilization and promote practical solutions. We kindly requested KS's assistance in arranging meetings and presentations on these topics (with positive feedback) to gain valuable insights and practical experiences that can be implemented in our local context, ultimately strengthening collaboration and knowledge exchange between our organizations.

The participants will include employees from MIRD SR: National Focal Point and colleagues from the Section of Innovation and Strategic Development.

Expected period of the implementation is in March 2025.

ANNEX I – RULES FOR AWARDING GRANTS

1) Introduction

- a) The involvement of the members of the JCBF in the selection process is an additional, extra task, unrelated to the standard functions of the JCBF as defined in the Regulations, Bilateral Guideline and the Statutes and Rules of Procedure.
- b) Unless otherwise stated in this document, the Statutes and Rules of Procedure, including, but not limited to chapter IV point 2 (decision-making) shall not apply.

2) Basic procedural rules

- a) The members express their opinion on the Grant Applications through electronic voting, organised by the NFP. In case of Open Call, voting shall be supported by a scoring chart, filled in in line with the selection criteria. Alternatively, a statement confirming that the member agrees with the opinion and scoring chart of the National Focal Point shall suffice.
- b) While the members agree that it is not possible to reach consensus on each and every Grant Application submitted, the members endeavour to closely cooperate in order to make sure that the votes and objections of any of the other members are carefully considered. Mutual trust and confidence should be applied whenever an objection is raised.
- c) If a member votes against a Grant Application or if an objection is raised, proper justification is required. The justification shall be detailed enough to enable the applicant to understand the reasons for the rejection of the application and shall follow the selection criteria.
- d) Representatives of Liechtenstein and Iceland are relieved from assessing the Grant Applications submitted in the Calls where only Slovak and Norwegian organisations are eligible to apply.

3) Rules of nomination

- a) The right of nomination of the person carrying out the voting (hereinafter referred to as “the assessor”) on the Grant Application belongs to the representative of the member in the JCBF (hereinafter referred to as “the representative”).
- b) The assessor might be the representative him/herself, his or her deputy in the JCBF or any other person.
- c) The representative shall notify the NFP about the contact details of the assessor (e.g. in an e-mail).
- d) The representative may also nominate several assessors. In that case, the Grant Applications shall be circulated to all of them; however, every member has only one vote.
- e) The nomination can be revoked by the representative.
- f) The nomination is not contingent of the particular representative, e.g. in case a new representative becomes member in the JCBF.

4) Criteria, voting and FIFO principle

- a) Formal and eligibility criteria shall be elaborated by the NFP and submitted to the JCBF for comments along with the text of the Call.
- b) Grant Applications not meeting formal or eligibility criteria, evaluated by the NFP, shall be rejected by the NFP. This does not prevent the re-submission of the Grant Application.
- c) Applicants whose applications were rejected due to non-compliance with formal or eligibility criteria have the right to appeal to the NFP, or re-submit the application. In case the appeal is successful, the original day of the submission of the application is considered when applying the FIFO principle.

- d) Selection criteria shall be elaborated by the NFP, approved by the JCBF and published along with the Call.
- e) In case of open calls, the assessors shall vote “FOR” or “AGAINST” the Grant Application or formally “ABSTAIN” from voting.
- f) In case of travel grants, the assessors may vote “FOR” or raise „OBJECTION” against the initial opinion of the NFP.
- g) FIFO (First In First Out) principle means that the applications are evaluated in the exact same order as they were received by the NFP. The NFP automatically reserves funds for the financing of the application after it is delivered.
- h) The call is closed if the amount of funds reserved tops the call allocation, however, a certain number of Grant Applications delivered in the meantime can be put on a reserve list (pipeline) and funded in case of savings in, withdrawal from or rejection of other Grant Applications or in other similar cases.

5) Procedure for awarding grants under an open call

- a) Every Grant Application meeting the formal and eligibility criteria is circulated to all JCBF members, along with the NFP’s initial opinion. The opinion represents the vote of the NFP as the member of the JCBF.
- b) Deadline for selection and voting is generally 5 working days. Within this period, any member may enter scrutiny reservation. Entering the scrutiny reservation suspends the time limits for a maximum of 5 working days. Members that remain silent are considered to have supported the NFP’s opinion (vote).
- c) The Grant Application is supported if it is voted “FOR” by **all, but at least three** members (hereinafter referred to as “the quorum”).
- d) If quorum is not reached, the deadline is prolonged by another 5 working days. The assessors shall be notified and requested to vote by the NFP. If, at the end of this period, the quorum is still not reached, the application shall be rejected and the reservation of funds cancelled.
- e) If the quorum is not unanimous, a discussion shall be held in order to reach consensus. Following the discussion, the NFP shall organise a new round of voting that shall be completed within 5 working days. If consensus still cannot be reached, the Grant Application shall be rejected and the reservation of funds cancelled.
- f) The members may make comments in order to improve the quality of the Grant Application. Comments shall be entitled as “substantive” or “minor”.
- g) In case substantive comments are received, the Grant Application needs to be modified within a period set by the NFP and circulated to all members again. The reservation of funds shall not be cancelled until the new assessment by the JCBF members is completed.
- h) Procedure under points b) – g) shall apply *mutatis mutandis* to any substantive modification of an already supported Grant Application.

6) Procedure for awarding travel grants

- a) Every Grant Application meeting the formal and eligibility criteria is circulated to all JCBF members, along with the NFP’s initial opinion. The opinion represents the vote of the NFP as the member of the JCBF.
- b) The NFP shall reserve funds for the financing of the Grant Application, irrespective of its opinion.
- c) In case the opinion of the NFP is positive and no objection is received within three working days following the circulation of the application, the Grant Application is *supported*; otherwise, the application is *rejected* and the reservation of funds cancelled.
- d) In case the opinion of the NFP is negative and **all, but at least two voting** assessors raised objection against the opinion, the Grant Application is *supported*; otherwise, the application is *rejected* and the reservation of funds cancelled.

7) Procedure for pre-defined initiatives

- a) The NFP shall approach the applicant for a pre-defined initiative well before the estimated start of the implementation of the initiative and request the submission of the Grant Application.
- b) The NFP shall, in close cooperation with the applicant, make all efforts to ensure that the Grant Application properly reflects the concept of the activity listed in the Work Plan.
- c) Once the Grant Application is fully developed, it shall be circulated to all JCBF members for comments within a deadline of 10 working days.
- d) In case substantive comments are received, the Grant Application needs to be modified and circulated to all members again.
- e) If no substantive comments are received within the deadline, the Grant Application is considered approved.
- f) Procedure under points b) – e) shall apply *mutatis mutandis* to any substantive modification of an already supported Grant Application.

8) Final decision

- a) Final decision shall be issued by the NFP (statutory representative or designated person).
- b) No appeal procedure shall apply on the final decision.

9) Final provisions

- a) Deadlines shall be calculated as of the day following the day the action was taken.
- b) Working days are those days considered working in both the Beneficiary State and the EFTA States.
